MRA – Who are we? – What are we for? – What have we done? – What can we do next? – How can YOU help?

The Residents' Association, formed in 1932, was and still is a key campaign body protecting the interests of Mottingham's Residents and promoting its activities through Newsletters and via its website www.yourMRA.org. Previous issues of newsletters going back to 1972 can be found in the History section of the website providing a fascinating insight into the development of the area. It seems that much effort was expended discussing antisocial behaviour and unacceptable planning applications, and traffic safety issues; nothing new there then!

Committee meetings are held every two months (except July) in the Methodist Church Hall, and this year's Annual General Meeting was held in May in the Oddfellows Hall in Beaconsfield Road Hall. Councillors for the Mottingham and Chislehurst North Ward (Bromley) and those for Mottingham, Coldharbour and New Eltham Ward (Greenwich) report to committee meetings and contribute to discussion. Meetings are also attended by Police representatives from both boroughs when available.

All our officers are volunteers and rely on the support of local residents. We aim to co-ordinate and provide assistance and information as well as protecting our social and physical environment. We organise decorations for Remembrance and Christmas as well as maintaining longer term installations such as the Village signs.

The MRA has (we think) one of the highest levels of resident representation in London and has the respect of local authorities. We still lack active representation from the retail sector. There seems to be little incentive for our local shops to form a collective body, probably due to their small number, and lack of corporate interest such as car parks. Nevertheless, we are grateful to those businesses who faithfully contribute to festive light installations and requests to display posters.

The function of this newsletter is to maintain contact with those residents with less physical and technical agility, and to précis and share the topics and discussions at the Annual General Meeting.

VOLUNTEERS NEEDED

We are always ready to welcome local residents (not just owners) to the Executive Committee and we also would like to have another 12 volunteers to assist with distributions to a patch of our community. REPORT OF THE ANNUAL GENERAL MEETING OF THE MRA 3rd May 2023 CHAIRMAN'S REPORT

<u>LiDL Supermarket</u> has been welcomed as a local source of reduced price supplies. The



store opened after a long and tortuous planning process. It was acknowledged that the store was not the first choice of many residents as a replacement for the Porcupine. This did not reflect preference for Waitrose, as erroneously reported in SE9 magazine, but was based on traffic and pedestrian safety grounds. Moving forward, the MRA are

keen to encourage Lidl to engage with the local community, and to that end have had a very positive meeting with the area manager and the store manager the day after opening. Lidl kindly agreed to supply most of the food and drinks for the Coronation Flower Festival. They will donate their food bank collections to St Edwards' Church food bank, rather than the Bromley Living food bank, so keeping it local. They expressed keenness to contribute to other local organisations, groups and schools, so the MRA and LiDL will be working together with them on that.

<u>Defibrillators.</u> The MRA under the chairman's leadership has acquired three defibrillators for the benefit of the local population and visitors. Unbelievably thefts have occurred, but insurance supplied replacement devices have been installed, and cabinets are now locked with a keycode which is supplied by London Ambulance Service when needed.

Dorset Road Infant School

The Dorset Road Infant School site is now up for sale by Bromley Council. The proceeds from the sale will be ring fenced for improvements at Elmstead Woods Primary School, which is the now amalgamated school.

Mottingham Library

The Chairman strongly urged members to make use of the excellent facility. The Library offers a wide range of activities, including toddler groups, teenage reading groups, four other reading groups/book clubs, armchair London talks by Chris, CPR training, and access to computers. It is a designated safe and warm place. It is a massive community resource, less like a traditional library, more of a community centre, but if we, the local residents, don't use it in any way, it will be deemed as unused, unnecessary and ripe for closing down. So please, please use it!

TREASURER'S REPORT

Mr Laurie Bell advised that last year's audited accounts, up to 31/03/22, show subscriptions of £1,314. Within this year's accounts, there is income of £1,107 from 2021/22 that came in between 01/04/22 and 30/06/22, making total subscriptions for 2021/22 £2,421.

Subscriptions and some donations of approximately £100, amount to £2,429 for 2022/23. So, there is very little difference between the two years. 'SumUp' has provided unidentifiable income, (subscriptions and donations), of £493. Within this are higher than usual donations. People are invariably rounding up to £5 or £10. In 2022/2. Several road sheets were not completed or returned. So although the subscription income is practically the same as last year, it is from fewer roads. The closing bank balance is £27,507.96 of which £10,400 is ring fenced money from the Royal Borough of Greenwich towards street planters. MRA funds therefore total £17,107.96.

MEMBERSHIP SECRETARY'S REPORT

With the initial onset of COVID, our income stream and data collection were completely debilitated. We realised that to maintain any kind of survival, we would have to have a rethink. We managed to maintain social distancing for our Executive Committee meetings via Zoom and kept the website up to date.

The most profound and lasting effects on our way of working relate to our doorstep collection of subscriptions. Planned collections for 2020/21 were classed as socially unacceptable and we did a very belated collection for 2021/22, the remnant of which is reported on this year's accounts. This offered a new option to pay by bank transfer on the membership cards although 83% of the 912 20/21 subs were paid in cash. 150 members opted to pay on line of whom 43 did so.

We then looked into the possibilities of adopting new technologies for collection. Card readers were considered impractical to share amongst our many road representatives. A QR code system appeared to offer a suitable safe and secure solution which is economical and simple to use but necessitates use of a smart phone which many

economical and simple to use but necessitates use of a smart phone which many members may not use. A drawback of the system is that there is no detail of the subscriber other than a part card number. Thus we have no record of contributor identity or e-mail address for our street records unless they inform us separately. Doorstep collection in person has benefits in data quality and social connection, but there are some road representatives who are put off by the process and the attitude encountered on certain doorsteps.

The ongoing difficulty of voting management at the AGM has now been brought forward in our constitutional debate and will be fully addressed at the 2024 AGM.

PLANNING ISSUES

Planning issues of local interest are regularly monitored, with lists posted on the MRA Website. Should you have any concerns about planning issues we suggest you contact our Council representatives. The MRA has expressed opinions on the following issues:

BROMLEY AREA:

- **LiDL** The discharge of the remaining Planning Conditions was welcome, leading to Lidl's opening of their new store in April.
- Eltham College Grove Park Road boundary Removal of the Cherry Trees was resisted by the MRA but the school were engaging in outlining their proposals and explaining their reasons. New trees are being planted and the old metal railing has now been replaced and looks a lot better. There is welcome improvement in visibility on the corner of Grove Park Road and Mottingham Lane.
- Elms, Mottingham Lane MRA has objected to the controversial application to build a large house on the site given the land is designated as Metropolitan Open Land. This has now gone to appeal.
- **Coach House** at the Chantry, Mottingham Lane approved.
- **33 Devonshire Road** MRA recognises that new housing is a priority in the right location and with that in mind it raised comments but despite some pressure remained neutral with regard to the re-application for a pair of semi-detached houses. Consent to the much revised plans was granted by the Council.
- Cerises and The Croft in, or just off Mottingham Lane MRA is currently objecting to both schemes due to scale and bulk leading to a negative impact on surrounding properties.
- **Eltham College Science department**. MRA is pleased to see that works are under way to refurbish and extend.
- **Capel Manor College,** Mottingham Lane. Plans for redevelopment of the site, including increased community aspects, were approved and building appears to have started. The MRA Committee was keenly supportive of the plans which promise continuing and enhanced community contribution.

GREENWICH AREA:

- **35 Hartsmead** HMO conversion strongly opposed by MRA was turned down by Greenwich. Was again turned down on appeal and owners were instructed to demolish an unauthorised outbuilding.
- **Garage area between Court Road shops and Porcupine Close** opposed by MRA approved after modification.
- Bridge House on the corner of Crossmead and Court Road. MRA supported local residents by objecting strongly to the proposal which we considered a gross over-development. The original plan was subsequently withdrawn but replaced with what we consider to be an even worse proposal for 32

residential units on the site. Further objections have been lodged.

- Several new telecoms masts MRA objected as the proposed sites were not suitable in our opinion. The number of cabinets that accompany the masts also seem to burgeon with up to 7 causing a significant eyesore and possible pavement obstruction. All of these proposals have so far been refused. MRA did suggest locating one on the open ground along the A20 near King John's Walk where it could be hidden by the trees but nothing has come of this. The latest proposal to erect one by the car park at Mottingham Station was also refused although the MRA did not raise objections.
- Garage block on the alleyway behind the shops (numbers 47-73) on Mottingham Road/Sycamore Close. MRA Objected we believe the application has been rejected primarily because of access issues.
- Woodmere Fields. Intense and vigorous discussion is taking place around change of use of the horse grazing fields behind Woodmere. The land is Crown Estate property, and following historical legal shenanigans, there is a proposal to instal commercial allotments with contentious provenance. The horses have already been evicted, and residents have concerns about loss of amenities and possible future development. A 2,500 strong petition has been submitted to the Council. [Google "Roots Allotments" Ed]

OTHER PLANNING OF GENERAL INTEREST

PLANES

In early July an application to expand the number of flights from London City



Airport was unanimously rejected by Newham councillors over noise pollution fears. Nine neighbouring councils and four MPs for surrounding areas also opposed the proposals. An application to extend operating hours has been referred to the Planning Inspectorate. London City expects to consult

in 2023 or 2024 on its plans for new flight paths to be linked with London and south east plans in 2025.

TRAINS

Southeastern Trains introduced their promised timetable changes on 11th December. There was an immediate backlash from customers claiming that services were now 'unreliable' and 'dangerously overcrowded'. There were pictures in the press of serious congestion at London Bridge Station. In response two additional evening commuter services from Cannon Street were instituted by the end of January. In February additional changes were introduced in order to try and address the issues raised, and a further service on the Abbey Wood loop line has recently been added. .... and AUTOMOBILES

West Park and **West Hallowes** are still under review and discussion along with other access routes to and from the A20. The Greenwich Cabinet Member for traffic has visited the site in person. Discussions tend to be prolonged since control of major routes (including Court



Road traffic lights) fall under the jurisdiction of TfL and liaison with local authorities. Bromley authorities are looking at possible traffic calming measures in Grove Park and Court Farm Roads.


Mottingham Road Parking & Planters



Bromley Council is shortly to embark on installing a revised parking

scheme outside the shops. Redevelopment will include substantial planters amongst revised off-carriageway

parking for 8 cars similar to that in Eltham High Street. Unfortunately for some, charges will be made via the RingGo app or phone which have suffered critical reviews. Residents may be aware that Greenwich Borough's app of choice is PayByPhone so you will need both on your phone. This will



evidently disadvantage members of society with limited or non-existent access to mobile technology.

Planters are being installed by both Bromley and Greenwich councils. We will be directly involved and will be seeking volunteers to assist with ongoing planting and maintenance jobs.

RETAIL ENVIRONMENT

Upgrading of the street scene may have been prompted by the arrival of **LiDL**. New businesses have moved into Court Road and Mottingham Road and several existing ones have undergone refurbishment.

ROCKET & BOW has turned into a microbrewery called **BAT & BALL** – a welcome nod to the local WG Grace heritage. (pic)

BEDROCK CAFÉ Has become a Caribbean street-food outlet ARAWAK.

GOOD YEAR'S CHINESE is now RICE DROP Sri Lankan cuisine.

RIPPIN INK tattoo studio has rejuvenated as a children's playshop.

D PLATINUM SERVICES now occupy the former **ROOMS** kitchen & bathroom shop. **TAN LINES** have replaced **MOTTINGHAM DIY** (different sorts of paint! Ed)

JARMAN & DIXON (Mottingham) PHARMACY, MEM'S CAFÉ, and MOTTINGHAM SUPERMARKET have all had welcome makeovers.

There are still some sadly empty premises.



OBITUARIES

We have sadly lost two notable West Park residents this year **John Perkins**



John and Cathy moved to Mottingham in 1993 and within a few years he was Chairman of MRA (and the Allotment association). As in his professional life, John was always a great believer in fairness and went out of his way to help people who thought they were being treated unfairly.

Among the issues which came up during his time as Chairman was graffiti which appeared in the village – particularly to the north of Court Road. The attendance at the meeting on the subject showed just how much local residents cared about their surroundings and John never forgot that.

During the years of his involvement with the Residents Association John was involved with urging increased police patrols in the Village – particularly to stop the number of youths drinking alcohol in the Street. He was part of the campaign to save Dorset Road Infants School and with his Allotment hat on helped to dig up the Japanese Knotweed threatening to engulf the playground.

He was part of the creation of the Village sign and was most amused at Ross's impersonation of W.G.Grace and posed under the sign disappearing in clouds of smoke as Greenwich Council operatives used noisy equipment to remove the zebra crossing throughout the ceremony.

He was part of the Hands Off Our War Memorial when the council tried to make the surround larger and safer but (fortunately) admitted they were planning to make it look like the roundabout between Mottingham Lane and Court Farm Road with much excess signage.

John found humour in all he did. He was very amused when Greenwich Council planted the wrong trees in West Hallowes and it was found they would grow to at least thirty foot and probably block the road. They were removed at his behest but suckers continue to appear to this day.

John retired in 2009 and moved to Suffolk where it was no surprise that within a few months he was Secretary of the Allotment Society and of the Residents Group. He died thirteen years after we left Mottingham but judging by the number of cards and tributes I received, he was obviously not forgotten. (Cathy Perkins)
